## **Minimum Qualifications**

**Resident Physician (Doctor) (One post):** M.B.B.S. Degree in any one of the Schedules to the Indian Medical Council Act, 1956 (102 of 1956) and must be registered in State Medical Register or Indian Medical Register.

**B) Consolidated Monthly Emoluments:** Rupees 70,000/- (Rupees Seventy Thousand).

**C) Desirable:** Post Graduate medical Qualification recognized by the MCI. Preference will be given to MD in General Medicine. Attending medical care of Teachers/Staff / Students (Male/Female) in Educational Institution. May be required medical needs by 24X7. Selected candidate (Male/Female) will have to reside in the University campus, accommodation will be provided by the University. Retired doctors will be preferred up to the maximum age of 70 years.
